You are a registered participant in one of the most challenging and comprehensive training courses in Rapid Intervention in the nation. The endeavor of which you are about to embark on is the most valuable, honorable and courageous investment in yourselves, your families and loved ones as well as to our brother firefighters across the country that you can make.

R.I.C.O. Rapid Intervention Company Operations 2012 will begin with registration check in and opening ceremonies this year in Elmhurst, Illinois. The location is the **Elmhurst Fire Department Fire Tower and Classroom at 910 N. Addison St. in Elmhurst, Illinois 60126**. We suggest that for geographical and street location information from your individual areas that you go to www.mapquest.com which will provide you with several ways and views in getting there. Those of you who are arriving by air should acquire detailed directions again through www.mapquest.com from either the airport or your accommodating hotel.

In order for check in registrations to run smoothly we are asking of you to have the following items while making these suggestions:

- Arrive on time. 0800hrs Check-in/All training programs begin at 0900hrs and end at 1700hrs daily.
- Make sure to have some formal type of identification (driver's license, department ID etc.)
- Make sure to have a copy of proof of registration/payments/billings/payments on site/department P.O. information etc.
- Make sure to check in your turn out gear this means full PPE/SCBA/Spare Cylinder/Face Piece. For those of you being issued an SCBA you will be assigned one. This year our sponsor **Tyco/Scott** will be supplying SCBA to those only traveling by air and who have notified **RICOFIRERESCUE INC** prior to their arrival at this course. If you have other circumstances requiring an SCBA and spare cylinder please contact us immediately. Make sure all SCBA's and personal equipment is clearly marked and labeled. You will be directed to this area when you arrive. Your gear and personal equipment will not be separated.
- Any personal tools such as Halligan Bars, Axes, Hand lights etc should be clearly marked as yours. We always suggest to those of you who are traveling by ground that you bring a Halligan bar, axe or small tool of choice. Make sure they are explicitly marked.
- This year all local area participants are required to bring a hand light. Again make sure it is explicitly marked.
- Vehicles will be directed into the parking areas when you arrive.
- Be patient when going through the registration check in process and be orderly.
- Make sure to supply a personal phone number that you can be contacted at as requested at the registration desk.

Participants will be involved in the classroom during morning hours only on the first day. The hands-on training begins immediately after lunch this day and will continue to 1700 hrs.
